# Environmental Objectives

## Compliance with Environmental Regulations:

1. Comply with all environmental regulations and strive to exceed the minimum requirements set by local and international laws.

## Waste Management:

2. Reduce other office waste by the end of 2024 by 50% compared to 2023.

## Energy Conservation:

3. Reduce energy consumption by the end of 2024 by 5% compared to 2023.

## Sustainable Procurement:

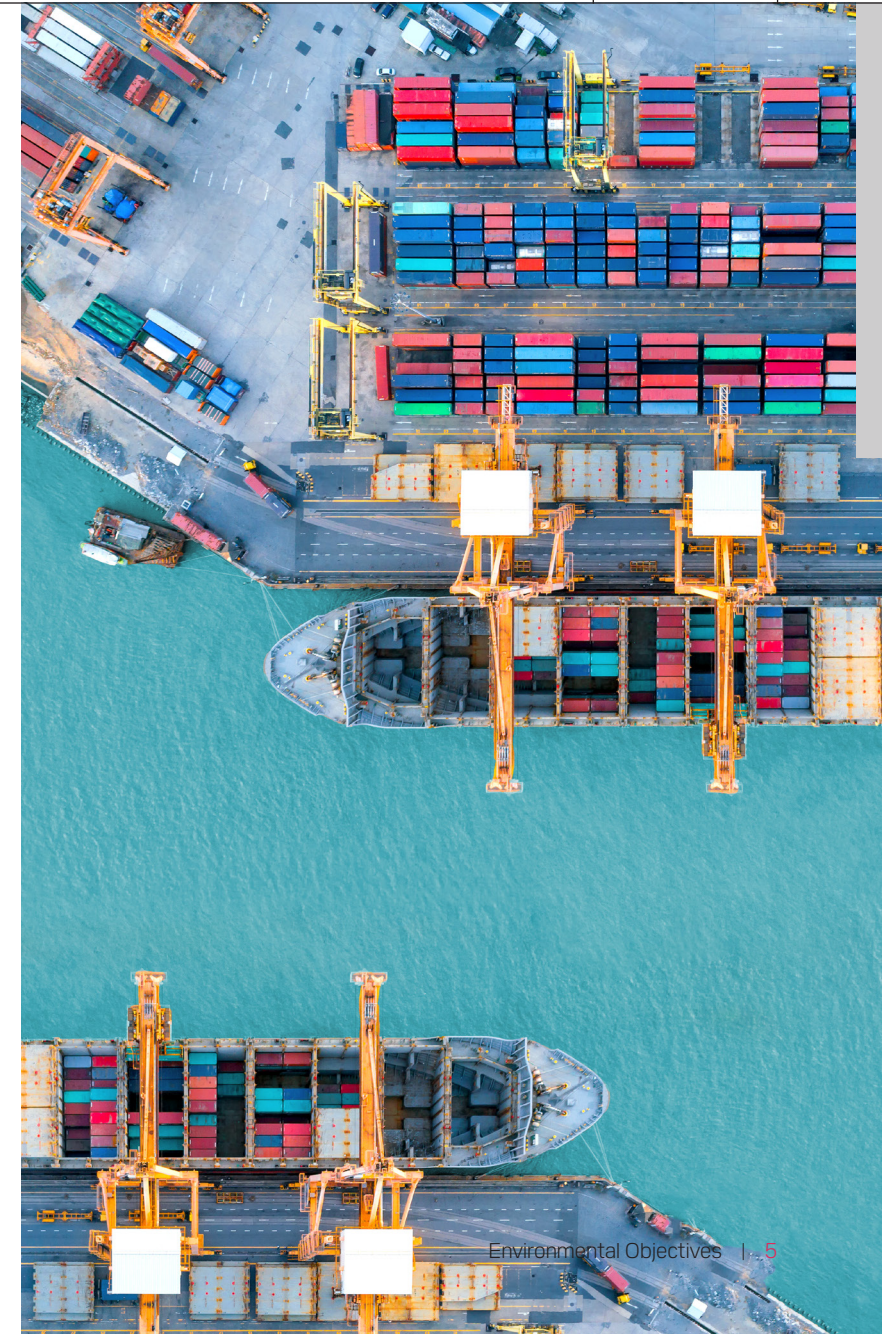
4. Expand the product portfolio to 25 greener products by the end of 2024

## Emissions Reduction:

5. Set a baseline for the emission calculation of inbound and outbound transport in 2024.
6. Introduce a more sustainable printing paper (100% sugarcane paper) and replace all the printing paper with the more sustainable option by the end of 2024.
7. Reduce paper consumption by the end of 2024 by 10% compared tot 2023.

## Environmental Awareness:

8. Train all Imres staff on the relevant aspects of the Environmental Management System
9. Engage with and measure how our suppliers adopt sustainable practices in the supply chain
